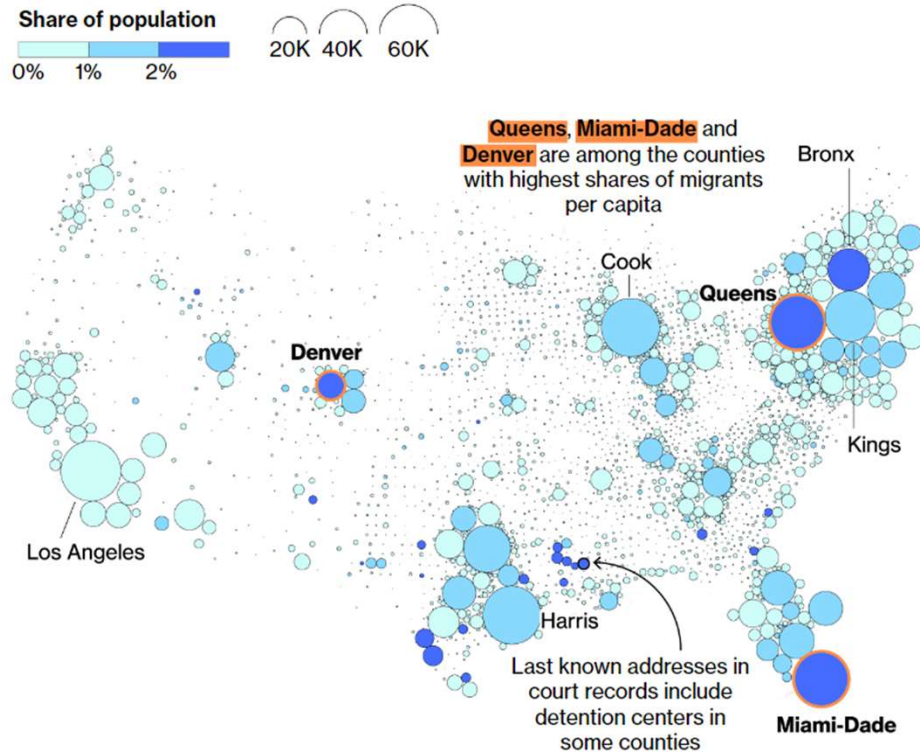

## New Migrants Made Up More Than 2% of People in Some Counties

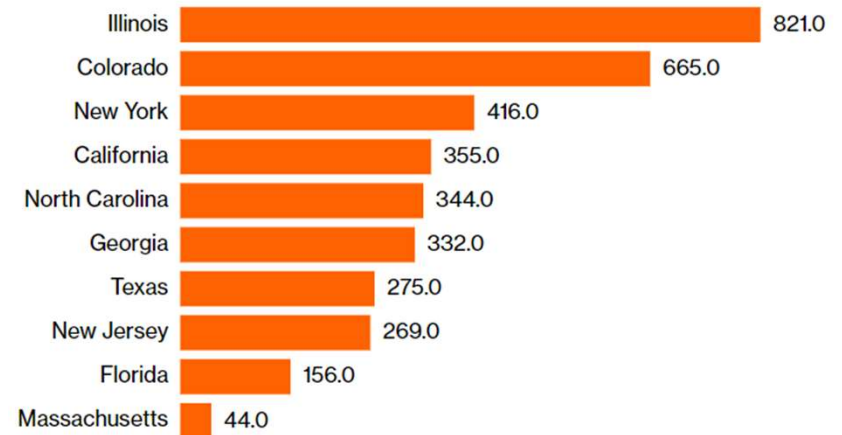
Number of migrants with new immigration court cases in 2023

# Common Issues

- Funding
  - Federal funding is scarce; some funding as available through Shelter and Service Program, but not a lot
  - Most jurisdictions are relying on a combination of local, state funding along with private philanthropy
  - Stable long-term funding key to development of long-term solutions
- Housing: Short-term rental assistance and long-term rental assistance challenged due to funding and lack of suitable space

- Case management
  - Both Denver and Chicago have capitalized on this special expertise of community-based organizations by funding trusted community-based organizations to provide case management support services to people seeking asylum staying in shelters

- Access to legal services

# Lessons Learned from Other Cities...

- Embrace out of the box thinking...challenge yourself/organizations to advocate in circumstances that would otherwise prevent response
- Pre-identify and prioritize facilities for sheltering mission
- Develop an emergency staffing plan
- Develop a contingency transportation plan across all modes

# Situation and Assumptions

- Assistance for Immigrant and Refugee communities
  - Current lack of resources (housing, funding)
  - Sheltering funding directed at homeless population
  - Also need case management, other services
- Emergency Management
  - Large, rapid influx of immigrants/refugees/asylees by bus or plane (>100)
  - EOC activation with ESF 6
    - Stand up reception center and short-term (2-3 days) sheltering operation
  - Executive Office
  - Affected jurisdiction(s)

### PLAYBOOK OVERVIEW

The scope of this Migrant & Refugee Arrival Playbook is to address initial roles and responsibilities of King County agencies in responding to unplanned arrival of mass migrants / refugees into King County. This Playbook does not address State and Federal sponsored Repatriation efforts facilitated within King County by Washington State Department of Health and Human Services (DHHS).

This Migrant & Refugee Arrival Playbook is designed to accomplish the following:

- Serve as a training aid to familiarize the reader with the roles and responsibilities of [partners](#);
- Offer operational guidance to responsible partners and decision-makers by providing thresholds and checklists; and
- Outline the flow of information among partners.

### PREPAREDNESS

King County has, and will continue, to welcome migrants and refugees entering and resettling inside of the county. Migrants and refugees may enter King County at any time as individuals or as part of a group. King County Office of Emergency Management in conjunction with enterprise partners will conduct preparedness activities. This phase includes critical tasks and activities necessary to build and improve the Counties' operational capabilities to prepare for, respond to, mitigate the impacts of, and assist with recovery in the event [a large number of migrants](#) and/or refugees arriving in the area.

# KC OEM Migrant Arrivals Playbook

- Address initial roles and responsibilities of King County Agencies and partners
- Unplanned mass arrival of migrants/refugees into King County
- Not for Federal-sponsored and State-managed repatriation efforts
- Preparedness activities
- Advanced notification of mass arrival
- Imminent mass arrival
- Mass arrival (no-notice)

# KC OEM Migrant Arrivals Playbook

- Establish coordination group
  - Review guidance from state and federal partners
  - Sharing of situational awareness
  - Inventory of potential housing options
  - Review contracts with service providers
- Equipment and supplies
  - Mass care caches (cots, blankets, pillows, other mass care supplies)
  - Hydration, washing, sanitation
  - Feeding, security, other wrap-around services
- Other considerations
  - Interpreters
  - Case management services

# KC OEM Migrant Arrivals Playbook

- Notify appropriate and relevant officials (city, County)
- Engage coordination group
- Assess reception center, shelter, and other resource capabilities
  - County-owned/operated facilities for potential options
- Ensure law enforcement is aware
- Determine need for health/medical assets
  - Engage Medical Reserve Corps as necessary
- Determine/choose sheltering/housing options
- Call with State partners for long-term sheltering needs
- Coordinate messaging

# Early Seattle Planning: No Notice Bus Arrival

- Asked the question: What if a bus shows up in the middle of the night?
- A: Leverage existing processes beginning with emergency sheltering
- Planning assumption: this would be a short-term solution
- Mission: Get them off the street and out of the elements
- Limitation: Using emergency shelters/rec centers only buys a few days and cannot be extended

# WA Intergovernmental Task Force on Asylum Seekers

- Initially convened to address situation in Tukwila
- Co-chaired by WA DSHS and Seattle OIRA
  - State, county (King), and city (Tukwila) officials (elected and appointed)
- Information sharing and situational awareness
  - Individual efforts of various entities
  - Coordination
- Expansion of Task Force
  - Federal agencies
  - Congressional staff
  - Other cities in King County

# HB 2368

- Coordinate statewide efforts of immigrant needs and includes \$32 million
- Gives the authority to serve those ineligible for federal assistance and engages with locals on doing that
- More than \$25 million is poised to go to the State's Office of Refugee and Immigrant Assistance (DSHS)
  - \$5 million to King County
  - \$2.5 million to the City of Tukwila, which is home to Riverton Park United Methodist Church
  - \$1 million of it would go to school districts that have seen a significant increase in homeless students seeking asylum
- Contract with CBP to provide services (in other words DSHS coordinates and does not provide services)
