You further agree to wait to strike your display until **11:00 am on Thursday, April 17**. Tear-down times are from 11:00 am to 1:00 pm. Failure to comply will result in an **early strike fee of \$200** which will be charged directly to your credit card, following the close of the conference. The conference steering committee reserves the right to reallocate booth space.
